**General Comment:**Spill Inspection

Around 1:15 pm on 12/22/2019 Inspector received call from a neighbor that there was a spill on the Kinchloe well location. Neighbor said that the well was shut in now. Inspector contacted operator and two vac trucks and a backhoe brought to location to contain oil and produced water. Apparently the treater dump valve got stuck and the 2-300 bbl oil tanks over ran filling the berm, the berm failed in two places and oil/produced water flowed down the access road to the well and off location into a winter wheat field. Inspector asked the vac truck drivers to get the free oil and the backhoe operator to berm the stained soil that was recovered. The landowner was made aware of the situation. Operator was asked to contact Washington County LGD and complete a Form 19I.
