Operator Comment: Foundation did not remove the submerged line at the time of the well and battery abandonment because a nearby pipeline marker indicated that the line was operated by Kerr McGee/Anadarko. The flange and check valve on the line support the belief that this is a sales line, rather than a flowline. Kerr-McGee was able to remove the line when the gravel pit drained the area in order to mine it.
