 On Thursday, December 26th, I supervisor Adam Kraich performed an inspection of the Jodster South 24-25HZ pad, operated by Occidental Petroleum Corporation, in Larimer County, Colorado.  
 This inspection is a follow up to inspection document #694400263, that identified potential non compliance of rule 802.b for low frequency noise.  
 In this inspection, measurements were taken as guided by rule 802.b.  
 A sound survey was performed 25' from the complainants home (40.377551, -104.950916).

 67 DB is non compliance under rule 802.d. A corrective action is assigned to the location, with a timeframe of 72 hours. A follow up inspection will be completed on 12/30/2019.  
 I spoke with OXY rig and compliance management on site on 12/26 who have begun mitigation efforts in regard to the low frequency issues.

Corrective Action: **Comply with Rule 802. For low frequency issues, obtain a low frequency impact analysis and identify control measures.**
