ISSUANCE OF THIS PERMIT DOES NOT CONFER A WATER RIGHT
CONDITIONS OF APPROVAL

- 1) This well shall be used in such a way as to cause no material injury to existing water rights. The issuance of the permit does not assure the applicant that no injury will occur to another vested water right or preclude another owner of a vested water right from seeking relief in a civil court action.
- 2) The construction of this well shall be in compliance with the Water Well Construction and Pump Installation Rules 2 CCR 402-2, unless approval of a variance has been granted by the State Board of Examiners of Water Well Construction and Pump Installation Contractors in accordance with Rule 17.
- 3) Approved pursuant to CRS 37-92-602(3)(b)(I).
- 4) The use of ground water from this well is limited to fire protection, ordinary household purposes inside one (1) single family dwelling, the irrigation of not more than one (1) acre of home lawns and gardens and the watering of domestic animals. This well is to be known as the Norman #1.
- 5) Approved for the change of use of an existing well constructed in November and December, 1979, for the purposes of coal-bed methane gas production. The total depth of this well is 4934 feet (plug back depth) below ground surface. The perforated interval is in the Williams Fork Formation at 3730 feet to 4934 feet below ground surface.
- 6) The maximum pumping rate shall not exceed 15 GPM.
- 7) The average annual amount of ground water to be appropriated shall not exceed one and one-half (1 1/2) acre-feet.
- 8) This well shall be constructed not more than 200 feet from the location specified on this permit. *Done 1/22/93*
