While there, I observed a shut in wellhead.

During this inspection the following possible compliance issues were observed:

1. 2 unused risers (LO/TO dated: March 2019) at wellhead. PLEASE REMOVE AND COMPLY WITH RULE 603.F. (Corrective Action Date: February 7, 2020) See attached photo #3.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
