One soil sample will be collected from the center of the former produced water tank location in accordance with Rule 905 b. The soil bore will be advanced using a hand auger to a depth of approximately 5 feet below ground surface. The tank was buried to a depth of approximately 3 feet below ground surface. The soil sample will be submitted for laboratory analysis of BTEX, GRO, DRO, pH, SAR, and EC. A site figure with the proposed sample location is provided as an attachment to this Form 27.
