General Comment:

On January 6th, 2020, Reclamation Specialist Trujillo conducted a Final reclamation and stormwater inspection at Diamond Back Drilling & Supply Inc's Emerald #251 location in Rio Blanco County, Colorado.

It was observed that pipe debris remains on the Location. At the time of inspection, Location covered in snow prevented the Reclamation Specialist from conducting an accurate assessment of the reclamation. Follow-up inspection will be needed in a future growing season.

The following alleged compliance issues were observed during this inspection:

- Pipe observed remaining on surface of the Location
