Comment This location is not in compliance with Rule 1003 vegetative standards. Interim reclamation areas have a high density of weedy annual vegetation, Kochia, which is not reflective of reference area vegetation. Refer to the attached inspection photos.

Corrective Action Perform reclamation in accordance to Rule 1003. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until the location meets Rule 1003 standards, including stormwater and weed management.

Interim reclamation activities shall be complete no later than 5/15/2020 or sooner, if possible, depending on environmental conditions.
