Conducted an on-site inspection at a Kerr McGee location:

Vogl 5-8A at API #05-123-19870 in

Weld County Colorado.

While there, I observed a shut in wellsite. Report shows it as SI since 2/1/2019.

During this inspection the following compliance issues were observed:

907.e Housekeeping: Stained soil around bradenhead. CA date 1/29/2020 see attached photo 3.

605.d Mechanical issue: WH valve appears to have a small leak. CA date 1/29/2020 See attached photo 4 and video.

At 1245 hrs I spoke with Shannon at the Kerr McGee office and explained the valve on the WH appears to have a leak and should be addressed ASAP, I was told they would notify the lease operator to have it tightened or replaced to solve issue.

Location is dry, weather is clear.

A follow up on this site inspection needs to be conducted to ensure the Compliance issues have been corrected to comply with COGCC rules.
