Citation Oil & Gas Corp. requests approval to retain this well in temporarily abandoned status. The well was originally abandoned due to low production. We are evaluating our options and the cost to stimulate the well and return to production. There is a CIBP set at 5148' with 2 sxs of cement on top isolating the Morrow perms at 5198'-5207'. The well is closed off to the atmosphere with valves and plugs in the tubing and casing.
