Operator Comments:

These operator comments are in response to NOAV 402067046. Specifically the demonstration of implementation of Corrective Actions:

- (1) Discontinue flow back of wells into open top tanks;
 (1)(a) Source a flowback crew with specialized equipment if the well won't bullhead;
 • If a well cannot be bull-headed and it is necessary to blow down the well, Noble will employ one of the following methods:
 o Preferred Method: The well will be blown down to an existing production facility with operable VOC combustors, if available.
 o Alternative Method: Noble will, where no production facility is available, bring in and utilize appropriate flowback equipment with combustors.
- (2) Reassess and repair grounding/bonding systems;
 • Noble and Noble's vendors have reviewed their grounding/bonding systems to ensure each system/method meets the minimum requirements of the NEC (National Electrical Code). All vendor systems were upgraded to bonded loop systems utilizing the wellhead as the termination point.
- (3) install continuous grounding system from gas buster to tank bottom to prevent "air gap".
 • The continuous grounding system from gas buster to tank bottom was eliminated from consideration as the most effective static electricity prevention tool. Noble will ensure that all tanks are fully and properly bonded and grounded and flow will be limited to 1m/sec (3ft/second) to prevent the accumulation of static electricity during fluid flow. Noble has updated its internal guidance for fluid flow rates to reflect this maximum rate.
