#### COMMENTS:

Willsource respectfully requests for continued TA status. This well is TA??d because of ongoing legal issues with the Forest Service (surface owner) and the BLM (mineral owner). This well had a packer set at 4600????on 11/17/2004 to TA the Rollins formation. The Williams Fork formation is TA because there is no production equipment on location. The master valve is closed at the surface, and the handles were removed for security. Willsource plans to produce this well by Oct 2020 if allowed to do so by the courts and or the involved agencies. Willsource will received and exception from the COGCC to dealy the MIT. A law suit currently in the Federal District Court in Denver could continue to delay this desired time line if a final resolution has not been reached. Our case is: WillSource Enterprise, LLC, v. Interior Board of Land Appeals, et al. in the U.S District Court for the District of Colorado. It is Case No. 17-cv-001887 (D. Colo.).
