The following corrective actions identified during the November 12, 2019 reclamation inspection are not addressed. Corrective action dates are back-dated to the November 12, 2019 inspection date, to document duration of non-compliance.

-Revegetation of areas not needed for production operations needs to be conducted. Stormwater and erosion controls are needed until revegetation areas are stabilized with desirable perennial vegetation.
