Trash on SW side of location and inside berm containing separators (appears to be ply wood from sound wall). PLEASE REMOVE AND COMPLY WITH RULE 603.F. (Corrective Action Date: February 2, 2020) See attached photo #13, 14.</p> <p>2. Unused equipment in berm containing separators (closest to ECDs). PLEASE REMOVE AND COMPLY WITH RULE 603.F.
