On 1/28/2020, Reclamation Specialist Trujillo conducted a final reclamation and stormwater inspection at CHEVRON USA INC # 16700's FEE 17 Location in Rio Blanco County, Colorado.

It was observed in this inspection that trash debris (barrel) remains to the west of the well. Location appears to have been recontoured/regraded. Utility equipment remains next to the access road. Unable to observe surface vegetation due to snow cover.

Inspection No. 675100368 dated 08/30/2014 required Operator to conduct reclamation. Form 42 #400755879 dated 12/18/2014 states corrective actions have been addressed.

It was observed in this inspection that additional reclamation activities per the corrective actions have been conducted; Location appears to have been recontoured and regraded per 1004.a. Location surface was covered in snow preventing reclamation specialist from conducting an accurate assessment of the reclamation; A follow-up inspection will be conducted in a future growing season to determine compliance

It was also observed that trash debris (barrel) remains west of the well, and oil and gas utility equipment (poles) have not been removed. See attached photo document.

Corrective Action: **Comply with 1004.a and remove trash debris and equipment remaining from the Location.**
