ISSUANCE OF THIS PERMIT DOES NOT CONFER A WATER RIGHT

CONDITIONS OF APPROVAL

- 1) This well shall be used in such a way as to cause no material injury to existing water rights. The issuance of the permit does not assure the applicant that no injury will occur to another vested water right or preclude another owner of a vested water right from seeking relief in a civil court action.
- 2) The construction of this well shall be in compliance with the Water Well Construction and Pump Installation Rules 2 CCR 402-2, unless approval of a variance has been granted by the State Board of Examiners of Water Well Construction and Pump Installation Contractors in accordance with Rule 17.
- 3) Approved pursuant to CRS 37-92-602(3)(b)(i).
- 4) Approved for the watering of livestock on a farm or ranch.
- 5) Permit 39377-F (canceled, March 19, 1992), was previously issued on July 23, 1991 for a change of use for this existing well. This well was originally constructed in the Summer of 1990, for coal-bed methane gas production. The total depth of this well is 3,970 feet, with a perforated interval in the Williams Fork Formation at 3,490 feet to 3,514 feet below ground surface.
- 6) The maximum pumping rate shall not exceed 15 GPM.
- 7) The average annual amount of ground water to be appropriated shall not exceed 1.5 acre-feet.
- 8) This well shall be constructed not more than 200 feet from the location specified on this permit.
