While there, I observed normal production operations.

During this inspection the following possible compliance issues were observed: Battery sign weathered and not legible. See photo #0499 with a corrective action date of 3/30/20. 1000 gallon methanol tank capacity inaccurate. See photo #0502 with a corrective action date of 3/30/20. Unused plungers and bumper spring at wellheads. See photo #0500 and #0501 with a corrective action date of 2/14/20.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
