**General Comment:**

This is an Abandoned Location Inspection for Well API#045-15128; APD first Approved in 2007 for Antero. Permit was Abandoned in 2011 by Antero. Cellar with Conductor Set was noted in 2016 Insp. Ursa by 11/1/16, reported preset conductor on Form 4 as per NTO. Conductor reported Plugged 6/27/18. Though reports verify that Conductor was Plugged & Abandoned, there is evidence of Well, Cellar & capped Conductor are visible. It does not appear that this AL Well was drilled on Location with Four PR Wells; therefore, this would be a Well Release on an Active Location, if not for Evidence of Well remaining on Site.
