Dear Mr. Grenfell:

On March 4, 1964, we wrote regarding subject well, and got a receipt indicating that you had received this letter, or that the letter was received by Lucille Grenfell.

As yet we have received from you no report or information on this well. Although we hesitate to use the provision of the law regarding penalties for violations, it does provide for a penalty of not more than \$1000 for each violation and for each day such violation continues.

All we are asking you to do at this time is to submit a completion report (OGCC-Form 5) and a plugging record (OGCC-Form 6), with a copy of the electric log on subject well.

If by May 15, 1964, I have not received an answer from you in this regard, I anticipate taking this matter up with our Director.
