Unless operations are commenced within 180 days after the date of approval hereof, this approval to drill will become null and void.

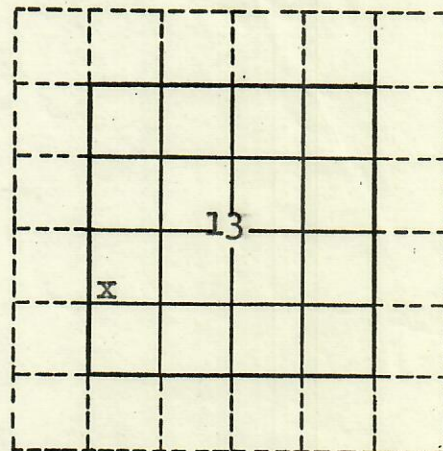

REMARKS: I propose to drill to a depth of approximately 60 feet then set 10 3/4" seamless casing; cement to surface; install blowout preventer; drill out with 7 3/4" bit and continue to drill open hole to a depth of approximately 3950' the set 5 1/2" casing and cement with 100 sacks of cement; core and run electric logthrough the Niobrara formation and if production is encountered, complete the well open hole and set the pumping unit. (Of course if production is not encountered, the well will be properly plugged and abandoned in accordance with the regulations of the Oil and Gas Commission of the State of Colorado.)
