Soil encountered below the produced water vessel will be field screened for volatile organic compound (VOC) concentrations using a photoionization detector (PID). In addition, visual and olfactory observations of the soil will be documented. A confirmation soil sample will be collected below the vessel and submitted for laboratory analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, total petroleum hydrocarbons (TPH) – gasoline range organics (GRO) by EPA Method 8260B, TPH– diesel range organics (DRO) by EPA Method 8015, pH by EPA Method 9045D, and electrical conductivity (EC) by EPA Method 120.1. If groundwater is encountered below the vessel, a soil sample will be collected from the unsaturated interval and submitted for laboratory analysis of the above-stated compounds.

## **SOURCE REMOVAL SUMMARY**

Soil encountered below the produced water vessels was field screened for volatile organic compound (VOC) concentrations using a photoionization detector (PID) [Table 2]. Two confirmation soil sample (SS01-W and SS01-E) were collected below the vessels and submitted for laboratory analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, total petroleum hydrocarbons (TPH)-gasoline range organics (GRO) by EPA Method 8260B, TPH-diesel range organics (DRO) by EPA Method 8015, pH by EPA Method 9045D, and electrical conductivity (EC) by EPA Method 120.1. The sample locations and excavation extents are illustrated on Figure 1. Soil analytical results are summarized in Table 1 and VOC concentrations are summarized in Table 2. The laboratory report is included in Attachment A.
