During this inspection the following possible compliance issues were observed:

3 well heads without signs.

Install sign to comply with Rule 210.b.

2 risers at separators and 2 risers at wells are unused and not capped.

30 days to remove risers.

C.A. Date 2/28/2020

Unused , unmarked flow line risers 24 hrs. to lock out tag out.

C.A. Date 01/28/2020

I spoke with Loren Prescott from Laramie Energy to make of aware of 24 hour corrective action timeline to lock out tag out unused uncapped risers.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
