Four grab soil samples were collected by Eagle Environmental for analysis of TPH-DRO by EPA Method 8015D, TPH-GRO, BTEX, and Naphthalene by EPA Method 8260C. Additionally, SS-01 @3' was analyzed for EC by Modified 9050A, pH by EPA 9045D, and SAR by 20B Saturated Paste.

The source will be removed through excavation of impacted soil above COGCC standards. Eagle Environmental will be on location to field guide the excavation and collect grab confirmation soil samples. A composite soil sample will also be collected every 500 cubic yards of overburden to ensure compliance with COGCC standards prior to using it as backfill. All soil samples will be delivered under standard chain of custody procedures to a certified laboratory for analysis of TPH-DRO, TPH-GRO, BTEX, and Naphthalene.
