The Columbine Springs wells have utility as producers at a sustained \$3.25/mcf. The CBM field's water production at lower gas prices makes the wells uneconomic. The wells are unable to produce without moving water. The wells have a cast iron bridge plug above the perms, and a wellhead master valve at the surface.
