On Tuesday 3/3/20 at approximately 14:00 hours, I, Inspector Corey De Paolo, Conducted a follow up inspection at MARALEX RESOURCES INC SOUTH SHALE RIDGE-68S98W /14NENE, Location #324270 in Garfield County Colorado.

Refer to document #696600432 inspection conducted on 8/2/19. Not all previous corrective actions have been completed.

While there, I observed normal production operations.

During this inspection the following possible compliance issues were observed: Tank label weathered and not legible. See photo #0697 with a corrective action date of 5/3/20. Location over grown with debris and weeds. See photo #0694, #0695 and #0696 with a previous corrective action date of 8/11/19. MIT required on well. With a previous corrective action date of 7/15/19.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
