Comment:

Pursuant to Rule 1004.a, upon plugging and abandonment of a well, all surface equipment shall be removed within 3 months of plugging a well. It was observed in this inspection that surface equipment remains on the Location: Sign at well has not been removed; Utility poles on and leading to Location have not been removed. Records show well was PA 10/5/2017; all oil and gas associated surface equipment should have been removed by 1/5/2018

Snow cover on the surface of the Location prevented reclamation specialist from conducting an accurate assessment of the reclamation/revegetation of the Location. A followup inspection will be conducted in the future growing seasons to determine compliance with Rule 1004.c.(2).

Corrective Action: **Comply with Rule 1004.a: Remove sign, and utility pole equipment.**
