On 3/2/2020 Catherine Roy conducted a reclamation and stormwater inspection. During this inspection the following compliance issues were observed:

- Impacted material identified during November 2017 inspection remains on the well pad as a stormwater pollutant. Corrective action date 1/19/2018 will remain to document duration of non-compliance.
- Stormwater erosion needs to be controlled by 4/3/2020.
- Areas on the well pad where vegetation is recently damaged by vehicle traffic/equipment need decompaction and revegetation during the spring 2020 seeding window.
