INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A partially buried produced water vessel (PWV) was removed from the Barron 39-18 location on January 29, 2020. Groundwater was not encountered in the PWV excavation. A liner was present beneath the PWV at this site. The PWV at this facility has been permanently removed. Soil samples from the excavation were submitted for laboratory analysis to determine if a release occurred. The general site layout, soil sample locations, and PWV excavation dimensions are depicted on the Excavation Site Map provided as Figure 1.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

On January 29 and 30, 2020, following removal of the PWV, soil samples were collected from the sidewalls and base of the excavation. The base soil samples were collected beneath the liner. The soil samples were field-screened for volatile organic compounds using a photoionization detector. Soil samples B01@4', N01@3', E01@3', S01@3', W01@3', B02@4', N02@3', E02@3', and S02@3' were submitted for laboratory analysis of benzene, toluene, ethylbenzene, and total xylenes (BTEX), total petroleum hydrocarbons (TPH), and naphthalene. The base soil samples were also analyzed for pH, specific conductance (EC), and sodium adsorption ratio (SAR). Laboratory analytical results for the soil samples indicate BTEX, TPH, naphthalene, pH, EC, and SAR concentrations and levels were in full compliance with COGCC Table 910-1 allowable levels at the extent of the excavation. The soil sample analytical results are summarized in Table 1, and the laboratory analytical reports are attached.

A total of 10 cubic yards of soil were excavated and transported to the Kerr McGee Land Treatment Facility in Weld County, Colorado, for recycling. The excavation area was backfilled and contoured to match pre-existing site conditions.

REMEDIATION SUMMARY

Laboratory results indicate that soil sample concentrations and levels were in compliance with COGCC allowable levels at the extent of the excavation. Groundwater was not encountered in the PWV excavation. Based on the analytical data presented herein, assessment is complete at this site and no further activities are required. This supplemental Form 27 has been prepared to request a No Further Action (NFA) determination for this site.
