Comment: There is vehicle rutting occurring along the access road. The ruts will potentially accelerate stormwater and cause erosion down the road. The road needs to be stabilized to prevent vehicle rutting. There is signs of erosion along the downward grade of the road in the side ditches. Sediment is accumulating in the outlet of the water bars. Additional BMP's will need to be installed to prevent erosion. BMP's must be implemented in accordance with good engineering practice and must be maintained until final reclamation is achieved.

Corrective Action: Install or repair required BMPs per Rule 1002.f.(2)C
