Comment	Approximately 200 musk thistles observed within the interim reclamation area. Revegetation is largely comprised of non-native intermediate wheatgrass, which is not consistent with the surrounding reference area vegetation. Review of aerial imagery and the well file indicates that reclamation was likely conducted in the late 1980s.
