Comment: 8/26/2016 TEP submitted an eForm 19 Initial when a pin-hole leak on the bottom of a Produced Water steel AST caused fluids to be spilled/released into an earthen secondary containment (F19 Initial Doc #401100232). A COGCC inspection was conducted on 8/29/2016 to examine the spill/release area and remediation activities. The impacted material from the spill/release was landfarmed on location just north of where the spill occurred (Doc #674300756). There was no evidence of a landfarm or excavation on location during 3/11/2020 inspection, see photos.

Corrective Action: Operator shall provide the status and update of Spill/Release 447506 on a Supplemental F19.
