Routine environmental inspection. Rem #7897 remains open and will require a supplemental eForm 27 requesting NFA status for closure. There are indications of a recent spill associated with the injection shed that require explanation and a Form 19 if the spill was 5 bbl of fluid or more.

Comment: See attached photographs. The presence of a drainage trench, heavy equipment scrape marks on the inside face of the containment berm and residual surface area of wet soil within and north of the injection shed and around the concrete vault indicate this was likely a reportable spill.
