Comments:

In Response to COGCC Inspection Document Number 696201067 regarding interim reclamation of referenced pad. Pad is managed by the BLM (Surface Management Agency). There are two drilled WOC wells (045-22809 and 045-22811). Laramie intent was to complete the wells in 2018 but postponed plans. Laramie has a filed a sundry with the BLM to interim reclaim the site as much as possible to the approved reclamation footprint which was part of the Federal NEPA and Permit Approval Process. Due to COA requirements of the original permit for visual screening of the pad from the High Lonesome Ranch, the established berm to the east end of the pad will not be disturbed as directed by the BLM. Laramie will reshape the NW, SW, and SE edges of the pad with remaining available soil and attempt to establish a 4:1 slope. The reclaim will be seeded with a BLM seed mix. The work will commence sometime after May 1, 2020 when Winter Timing Restrictions are lifted.
