	<p>Previous inspections (Doc.# 682504201 and 682504494) documented that compaction alleviation (cross-ripping) had not been conducted in accordance to Rule 1004. At the time of this inspection, it was unclear whether compaction alleviation has been performed per Rule 1004.; it does not appear the access road and well location were seeded. Weedy, annual vegetation was observed, not crop growth. Staff will have to conduct a future inspection during the active growing season to make an assessment whether compaction alleviation was performed based on vegetative growth.</p> <p>This inspection did document that the access road has not been properly contoured to match the surrounding landscape per Rule 1004. Refer to the attached inspection photos.</p>	
Corrective Action:	<p>Since compliance issues were observed (failed to contour the access road) and the access road/well location are not reflective of reference crop areas, the corrective action date remains the same.</p>	Date 07/07/2017
