Comment:

Previous inspections (Doc.# 682504199 and 682504492) documented that compaction alleviation (cross-ripping) had not been conducted in accordance to Rule 1004. At the time of this inspection, it was unclear whether compaction alleviation has been performed at the well location per Rule 1004. It does not appear the well location was seeded, only the access road. Staff will have to conduct a future inspection during the active growing season to make an assessment whether compaction alleviation was performed at the well location based on vegetative growth. Refer to the attached inspection photos.

Corrective Action:

Since the well location is not reflective of reference crop areas, the corrective action date remains the same.
