While there, I observed a workover rig.

During this inspection the following possible compliance issues were observed:

Tracking occurring onto Colorado State Highway 14 from the location entrance. See photos 2-4. Install or repair required BMPs per Rule 1002.f.(2)C

I spoke with Aran Cook about the tracking and he informed me that the tracking pad was ready to be installed and would be in place by Monday 3/9.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
