Reason for TA & 2019 details; A bottom hole pressure survey was conducted on this well as part of the Rangely Weber pressure monitoring program. The future plans; this well will be worked over and returned to injection in 2020. The casing in this well is isolated from the production zone with tow packers and tubing and closed valves on the wellhead. The well is economically viable in the current environment and is being worked over in order to return the well to service. The last witnessed and approved MIT was conducted on 4/13/2016.
