COMMENTS:

The laterals of the westernmost 8 SHL's at this location are being amended to have west-east laterals traversing through the S/2 of Sections 7 and 8.

Sundries are being submitted to reallocate the SHL of the easternmost 8 wells utilizing existing TPZ and BHL locations across the E/2 of Sections 18 and 19. TPZ and BHL do not change for this well.

The well names will change to better capture the lateral trajectory of the wells.

All of the original SHL's permitted at this location will be used; no changes to the surface disturbance are planned. Cultural Distance Information is unchanged for the location.

The amendments to the wells on this location will not affect WOGLA18-0080 submitted 7/5/18, approved 9/20/18. The previously approved notices, exception locations, and SUA are still valid.

1	Drilling/Completion Operations	Alternative Logging Program: One of the first wells drilled on the pad will be logged with an open-hole Resistivity Log and Gamma Ray Log from the kick-off point into the surface casing. All wells on the pad will have a Cement Bond Log with Gamma-Ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs shall clearly state "Alternative Logging Program - No open-hole logs were run" and shall clearly identify the type of log and the well (by API#) in which open-hole logs were run.
2	Drilling/Completion Operations	Anti-collision: Operator will perform an anti-collision evaluation of all active (producing, shut in, or temporarily abandoned) offset wellbores that have the potential of being within 150 feet of a proposed well prior to drilling operations for the proposed well. Notice shall be given to all offset operators prior to drilling.
3	Drilling/Completion Operations	Bradenhead Monitoring: Operator acknowledges and will comply with COGCC Policy for Bradenhead Monitoring during Hydraulic Fracturing Treatments in the Greater Wattenberg Area dated May 29, 2012.
