While there, I observed production.

During this inspection the following possible compliance issues were observed:

Gauge hatch open on south tank. See photo 2. Close and seal gauge hatches when not accessing tank per Rule 605.a.(9) by 3/30/2020.

Erosion gullies forming from center of location and moving north towards the Little Snake River. No BMPs observed. See photo 3. Install or repair required BMPs per Rule 1002.f.(2)C by 4/13/2020.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
