Eleven grab soil samples were collected by Fremont Environmental for analysis of TPH-DRO by EPA Method 8015, TPH-GRO, BTEX, and Naphthalene by EPA Method 8260B. Additionally, SS-01 3 Ft was analyzed for SAR by Soluble Nutrients by EPA 6020/USDA60(2,3A)-Dry Weight Basis, pH by Physical Parameters by APHA/ASTM/EPA Methods, and EC by EPA Method 120.1.
