While there, I observed a shut-in production well.
During this inspection the following possible compliance issues were observed:
Stained soil at pump jack. See photo 3. Comply with Rule 603.f and properly dispose of oily waste in accordance with 907.e by 4/21/2020.
Vertical heated separator less than 50 feet from heated crude oil tanks. 40.90355, -108.28435. See photo 1. Move equipment to comply with minimum 50 foot setback as per Rule 605.a.6 by 2/27/2015.
Landfarm mentioned in previous inspections. Not fenced. See photo 2. E&P Waste not properly stored, handled, transported, treated, recycled, or disposed per Rule 907. Contact COGCC EPS staff by 10/1/2018.
