While there, I observed production.

During this inspection the following possible compliance issues were observed:

Stained soil at pump jack. See photo 2. Comply with Rule 603.f, securely fasten all valves, pipes, and fittings to ensure good mechanical condition, inspect at regular intervals and maintain in good mechanical condition per Rule 605.d, and properly dispose of oily waste in accordance with 907.e by 4/21/2020.

Fenced area with oily soil. See photo 3. E&P Waste not properly stored, handled, transported, treated, recycled, or disposed per Rule 907. Contact COGCC EPS staff by 10/10/2018.

Two pits on location. See photos 4 and 5. Two pit ids with this location 100421, 100424. No pit permit on file. Please provide an update to kris.neidel@state.co.us on the status of these pits. Netting on pits should be maintained in good working order prior to use of pit. Submit an eForm 15 Pit Report to update COGCC records with current information to comply with rule 903.a by 11/24/2016.
