Snow cover on surface of the Location prevented Reclamation Specialist from conducting an accurate assessment of reclamation on areas not needed for production on the Location in accordance with 1003.b. Assessment will be conducting during a followup inspection.

Comply with Rule 1003.f and 603.f, and conduct noxious weed management and remove weedy debris around equipment. Weed management will need to be conducted prior to plant and seed head maturity, but no later than 7/31/2020
