This site visit was performed to assess Spill/Release Point ID #475456.</p> <p>The Garcia #1 appears to be shut in until repairs can be made to the gathering line south of the location.</p> <p>Salt staining is apparent along the access road. This continues to the intersection with Mira Sol Drive and flows through the culvert to an impoundment on the east side of the road. Stained vegetation and evidence of flow continue towards the head of the impoundment. No standing water was observed during this inspection.</p>	hughesjo	04/20/2020
