<p>Inspection #696200925 documented areas on the Location not needed for production, and required Operator to comply with Rule 1003.b.</p> <p>It was observed in this inspection that Operator appears to have constructed a berm between the production area, and areas not needed for production; no additional reclamation activities appear to have been conducted.</p> <p>Vegetative establishment on the current interim areas on the west and north ends of the Location is predominantly weedy, or areas are bare soil; no additional revegetation activities appear to have been conducted and stabilization controls installed.</p> <p>Fill slopes on the east end of the location have not been removed; topsoils salvaged from under the fill slope per 1002.b have not been replaced; areas have not been contoured to their original grade; revegetation activities have not been conducted.</p> <p>This corrective action has not been addressed and remains applicable.</p>	trujilloam	04/29/2020
