COMMENTS:

BP requests approval to replace the above ground P&A marker for this well with a below ground P&A marker.

The Jones GU B 1 well was plugged and abandoned in 1956 and is located on a well location with 2 active BP wells and 1 XTO plugged well. This pad is on agricultural land used for pasturing bulls. The P&A marker is 17 feet from the wellhead of an active well. The marker has become disconnected from the casing top by blunt force as a result of bulls on the well pad. Due to the proximity of this marker to the active well head and the need to remove it for any rig work, then reattach it and the impacts of the agricultural activity BPX is requesting authorization to install a below grade P&A marker onto the top of the casing in place of the above grade marker for safety of the landowner livestock and the continued operation of the active well.
