This included installing storm water BMP's, recontouring, decompacting, and revegetating the areas not needed for production operations. The location was mulched to assist with successful revegetation. Additional detail provided in attached photos. Consistent with LOGOS Operating's policy noxious weeds will continue to be sprayed annually and more often as needed. We will work with our weed spraying vendor to ensure that the areas in question are adequately sprayed and monitored in the spring of 2020 and going forward.
