FIR Document # 688401791 corrective action required Timber Creek to provide documentation that the COGCC approved use of a vacuum pump. As a courtesy Timber Creek was able to produce the documents from the previous operator and submitted those to the COGCC. FIRR Document # 402032022 resolved the corrective actions and FIR document 693501455 approved the corrective actions including the vacuum document in 2019.
