Comment:

Operator has performed some of the final reclamation requirements (i.e., remove gravel) at the associated offsite tank battery. However, there was very little germination of desirable species; therefore, it does not appear the tank battery has been seeded or it was a failed attempt. Refer to the attached inspection photos.

Operator should consider temporarily fencing off the area to keep vehicle traffic off and to help promote successful vegetation establishment to stabilize the area.

Also, much of the well location and well location access road has Kochia rosettes which will require future weed management.

Corrective Action:

Comply with Rule 1004 to perform final reclamation activities for the associated offsite tank battery no later than 11/15/20 or as soon as environmental conditions permit.
