"**LOCAL GOVERNMENTAL DESIGNEE** means the office designated to receive, on behalf of the local government, copies of all documents required to be filed with the local governmental designee pursuant to these rules." Pursuant to the rules of the COGCC, the Local Governmental Designee (LGD) may participate in COGCC procedures on behalf of the local government. LGD participation may include, but is not limited to, receiving notices and documents from the COGCC, submitting comments and requesting comment period extensions for drilling permit and location assessment applications, requesting meetings and consultations, requesting hearings, and requesting geodatabase information.
